PRESENTATIONS

Campus Safety and Security

Mark Childers, Associate Vice President for Campus Safety and Security

Associate Vice President Childers reported that he has hired a Technical Security Director who will begin February 9, 2015. Childers is recommending an increase to Baylor's police force by 10 officers in the next two years. He hopes to receive approval by June 1. Baylor has hired a Title IX Coordinator who is not under this department but who works with Campus Safety and Security.

Global Engagement

Dr. Jeff Hamilton, Vice Provost for Global Education The proposal is for a Council on Global Engagement, which would be a new standing committee.

Faculty-in-Residence (FIR)

Faculty-in-Residence Representatives Dr. Stephen Pounders, Dr. Ian Gravangne, and Dr. Jeff Doyle, Dean for Student Learning and Engagement.

Dr. Pounders shared that he is in his last year of seven years of service as a Faculty-in-Residence. The FIR meet together, however, the group requests that it be added to the official academic committees of the University, with regular reporting to the Faculty Senate. There are currently 13 faculty in residence. The plan is to have faculty in-house residents at all residence halls within the next five years.

ITEMS OF BUSINESS

Ombudsperson Recommendation

Senator Baldridge moved and Senator Patton seconded the motion to make a recommendation to the Provost that Senator Yancey's position as Interim Ombudsperson be changed to a permanent position. The motion passed.

Proposed New Committees

Global Education:

Discussion: Faculty input on an academic program versus a University mission. Pros: increases transparency. Added a procedure Representation from each academic unit meaning colleges. Rotating faculty would be for a period of 3 years, which is standard for Committee on Committees.

Senator Spies, as part of _____, suggested that it be a formal group.

The Faculty Senate will vote in February.

Baylor Council of Faculty-in-Residence:

The Senate reviewed the proposal to add the Baylor Council of Faculty-in-Residence to the official academic committees of the University, regularly reporting to the Faculty Senate.

Senator Baldridge moved to adopt the proposal with the amendment that a Faculty Senate representative would serve on the Faculty-in-Residence Council. Senator Beal seconded. The motion passed.

There is no BUPP policy that states the number of students who can be guests of the faculty at the McMullen Faculty Dining Center. At this point, the Interim Provost does not want to issue a policy but would rather make suggestions.
